Section II: Applicants are responsible for all costs of attending the university (4-5 years for freshmen; 2-3 years for transfer students). College costs are subject to change and increase an average of 5 percent annually. You must include supplementary documents/proof as indicated, and attach originals, **not** photo copies, in United States Dollars (USD) or shown at the applicable conversion rate. - Give the student the original documents and have him or her submit them electronically or make photocopies to mail or fax to us with the application for a Form I-20. The student will need to keep the originals to present to the consul at the visa interview.

SUPPORTING EVIDENCE REQUIRED:

- **Proof of income (*any of the following*) with most recent pay stub:**
Income tax returns or receipts, or
Pay stubs for the last six months, or
Bank/investment statements for the last six months.
- **Bank statement in your name only.** A monthly statement of balances and deposits.
If another person's name appears on your bank statement, that person must complete a separate affidavit. A letter from a bank officer will not be accepted.
